The death of Sagar Das, S., triggered a road blockade for around three hours by hundreds of local people.

Das, a resident of Daspara of the Baropatia-Natunbos area of Jalpaiguri district, went to an agricultural field at Nathuar Char, along with his brother Sahel. They had planted groundmuts on a plot and went there to check on the crop.

"A wild elephant that was nearby chased the brothers. Sahel managed to escape but the elephant caught Sagar by the trunk and tossed him on the ground," said a source.

Sahel raised the alarm and along with some others, rushed his brother to the super-speciality hospital in Jalpaiguir where doctors pronounced him dead.
